**Discovery on these cases should begin at once. To the extent counsel for plaintiff is in possession of the plaintiff's social security and medical records, copies should be immediately provided to defendants. Updated authorizations must be provided to RecordTrak now. For any case where the plaintiff was not deposed prior to death, no later than January 5, counsel for plaintiffs should identify the co-worker who will provide product identification evidence and schedule that deposition as quickly as possible.**

Judge Freedman will hold a status conference on these cases on January 8 at 9:30 am with the hope of scheduling a February trial date.
